

These are the Terms & Conditions for the 888 LIVE tournament in SÃO PAULO, BRAZIL. The Tournament Directors has autonomy of arbitration under any matters not provided for in this document. The decision they make is final and will always follow common sense, with a view to preserving the order and safety of the tournament.

Competitors entering any competition or event of 888 LIVE - SÃO PAULO at the time of registration agree in full with all rules in this document.

## EVENT STRUCTURE

### 1.1 EVENT LOCATION AND RESPONSIBLE COMPANY

The event will be held from September 6th to September 11th, 2017 at Casa Bossa - Shopping Cidade Jardim - São Paulo / SP - Brazil.

### 1.2 STRUCTURE

**1.2.1 Main Event** - Will be played over 06 days;;

**1.2.1.1** Qualifiers days – 1A, 1B, 1C, 1D, 1E e 1F

**1.2.2 High Roller** – Will be played over 02 days;

**1.2.3 Ladies Event**– Will be played over 02 days

**1.2.3.1** Tournament with a buy-in of R\$ 10,000.00 (Ten thousand reais), female audience will have a discount of 95% on registration.

**1.2.4 Last Chance** – It will be played in a single day,

**1.2.5 Flop O Mania 6Max** – It will be played in a single day - Exclusively for invited players.

**1.2.6 Celebidades Fundação Cafu** – It will be played in a single day;

**1.2.6.1** Exclusively for invited players.

### 1.3 SCHEDULE

Tournament timetable and the opening days of 888 LIVE - SÃO PAULO are available at <https://www.888poker.com/poker-promotions/sao-paulo-festival/> Registration will start one (1) hour before the start of each tournament. The organization reserves the right to change the schedule, without previous communication, if it deems necessary to the proper development of the tournament.

### 1.4 IMPORTANT NOTES

All participants are advised to arrive one (1) hour before the tournament for the registration and seating process. The starting time of the tournaments, as previously stipulated, will be strictly adhered to by the organization of the tournament. The organization is not liable for any personal injury, loss or irregularities in the operation of participants' personal objects and devices.

## **1.5 RE-SCHEDULE AND / OR CANCELLATION**

If for any reason the tournament can not be performed as planned due to technical problems, unauthorized interventions, fraud or other causes that are outside the control of the organization, that may in any way corrupt or affect the administration, safety, suitability, Integrity or the correct conduct of this tournament, the organizer has the right, in its discretion, to cancel, close, re-schedule or suspend the tournament for the term deemed necessary, without obligation to reimburse or compensate any competitor, with the exception of returning the registration fees to competitors already registered.

- A) In case of a cancelled tournament, only those who are unequivocally enrolled in it will be considered as clients of the Organizer, and effectively competitors of the event, until the date of cancellation.
- B) The achievement of a place in a "satellite" tournament, including online, is not, by itself, indicative of registration at the event.
- C) The registration process will only be considered complete and effective after the competitor receives your registration receipt.

## **REGISTRATION AND SATELLITES**

### **2.1 REGISTRATION AND SATELLITES**

Only persons over 18 years of age at the time of registration, with a valid ID with photo, may apply for 888LIVE.

- A) It is mandatory to present a valid photo ID at the beginning of the tournament. Proof of identity may be requested by members of the organization at any time during the tournament.
- B) Registration for third parties is not allowed.
- C) If the tournament for which the competitor signs allow re-entry, he may re-register if he is eliminated, in accordance with the re-entry limitations for the tournament.

### **2.2 VALUE AND FORM OF PAYMENT**

The buy-in cost for each tournament of the event will be announced through the <https://www.888poker.com/poker-promotions/sao-paulo-festival/> website. Payment must be made exclusively in national currency (Brazilian Reais), in cash or using debit / credit cards, on the day of the tournament. Registration fees, when paid using the debit or credit cards, will be increased by the fees that are charged by the companies that render the payment processing service, as authorized by Law 13455 of June 26, 2017. The rates are approximately 5% for debit cards and 10% for credit cards. There will be, at the registration desk, a table of registration values with the amount to be paid by the competitor depending on the form of payment used.

### **2.3 ONLINE SATELLITE SEATS**

The seats won in official online satellite tournaments in the 888Poker client are

Personal, non-transferable, and not refundable for cash. Competitors who have been granted access to the official online satellite tournament may be required to log in to their accounts for proof of identity.

Competitors who obtained access to the online satellite tournament that did not attend the Tournament (i.e. no show) until the end of the registration period of the event for which they A vacancy, waive the right to participate and will not be entitled to any refund or refund.

## **2.4 LIVE SATELLITES IN POKER CLUBS OR PARTNERS**

The vacancies won in satellite tournaments of poker clubs or partner companies of the Event are personal and non-transferable, that is, they are not negotiable, transferred or sold. These vacancies will only be recognized by the organization if clubs or companies that performed the satellites follow the guidelines agreed upon with STARS CLUB ITAIM and make the deposit referring to the total value of the vacancies, in an informed account by the organization, with a minimum of 7 days before the first day of 888 Live São Paulo.

Competitors who obtained access to the satellite tournament and did not attend the tournament (I.e. no show) until the end of the registration period of the same one for which they have won a the right to participate and will not be entitled to any refund.

## **2.5 LATE REGISTRATIONS AND ALTERNATES**

Exceptionally, at the discretion of the Tournament Director, the tournament registration can be extended. Participants enrolled during this extra period will occupy vacant tables. In the absence of empty seats, participants shall be considered as Alternates, and shall wait for competitors to be eliminated from the occupy their places. Alternate participants will be listed in a unified waiting list por your vacancy, and you can not cancel your subscription.

## **2.6 CANCELLATIONS, WITHDRAWALS OR TRANSFERS**

Once entered in the tournament, the competitor may only request the cancellation thirty (30) minutes before the start of the tournament. At registrations already made become personal, non-transferable and unencumbered. Transfers from registrations from one person to another are not allowed, except on an exceptional basis, when authorized by the Tournament Director for a relevant reason, before the start of the tournament

## **2.7 REGISTRATION RECEIPT AND IMAGE AUTORIZATION**

At the time of registration, all competitors must sign an a waiver players need to sign it once they are at the cashier, in which they declare that they are aware of this Regulation, accept all their provisions and agree with the rules regarding the use of sponsor's logos and brands described later in this regulation.

a) The event will be documented in photos and video by communication channels accredited by the general direction of the tournament. Parties or the entire event may be filmed and broadcast to the public on open and closed television, or live stream channels of the tournament may take place.

- b) Tournament participants are required to authorize the dissemination of their images internationally, without restrictions on any media. Such consent is given at the time of registration by signing the authorization term for the use of the image, which appears on the registration receipt. All competitors of the tournament give the organizer of the event free of charge the image rights and copyrights of material collected at the event.
- c) The competitors authorize the organizer of the event to give and transfer the images and media collected to third parties. The contestants agree to meet the requests of the organizers of the event for publicity, promotional or informative actions during their participation.
- d) All participants agree to release information regarding their cards to the official press of the event and show them to the cameras at the TV Feature table. The refusal will lead to disqualification of the participant, without the right to reimbursement of the registration. Competitors agree to attend press conferences, interviews, and photo shoots during the event whenever requested by the tournament direction.

### **2.7.1 Use of logos and clothing**

At the final table, a maximum of three participants will be allowed to use a logo from the same company that is different from the official sponsor of the event. The event director will have full autonomy in approving or rejecting items of clothing or accessories used by competitors during the event. They shall also be entitled to cover, hide or remove any logo, images, words used on the clothing or accessories of competitors that, in its discretion, are deemed improper to the transmission or dissemination by means of media available at the event.

## **AWARDS**

### **3.1 AWARD AND DESTINATION OF REGISTRATION**

Approximately 10% (Ten percent) of the best placed in the tournament will be awarded. for each tournament, a Structure Sheet will be posted on the website <https://br.888poker.com/poker-promotions/sao-paulo-festival/>, in this, the value will be described of the application. Of the amount of each registration, 82% of the value will be destined to the prizepool, 15% will be allocated to the rake (administrative fee) and 3.0% (three percent) of the total prize money of each 888LIVE will be retained for distribution in its entirety to the dealers and tournament staff

### **3.2 PAYMENT OF AWARDS**

Payment of any prizes may be made in cash, check, deposit into account, or a combination of these methods, at the discretion of the organization. Due to security issues, some payments

may not be made during the event, with the organizer having the right, up to 05 business days to make the payment after 888Live Sao Paulo.

### **3.3 TAX RETENTION**

Following the Brazilian tax rules, up to 27.5% of the net profit of the awards (Prizes minus registration) will be discounted at the time of payment. Receipts will be issued to the winning competitors. The award will be taxed in accordance with IRPF regulations..

### **3.4 AGREEMENTS**

The 888LIVE organization will not allow any type of agreement between players regarding the prize payments. Each player will receive the amount stipulated in the original award given by the organization.
